### 3. Update on heritage-related Council decisions

- I. James, Heritage and Urban Design Planner, provided an update to Committee regarding Council's approval of the recommendation from Heritage Richmond Hill related to the request by the property owner to repeal the designating by-law for 12370 Leslie Street. She also advised that the grant applications had received final approval.
- I. James advised that staff were in the process of drafting a staff report for the December 4, 2017 Committee of the Whole meeting in response to Council's direction that a report be prepared regarding the nomination of the David Dunlap Observatory property as a National Historic Site. She stated that the report prepared by staff provided information on the nomination process and guidelines for evaluating subjects of potential national historic significance.
- I. James provided information on the mediation meeting with the owner of 34 Oxford Street.

#### 4. 35 Wright Street – Status Update

I. James, Heritage and Urban Design Planner, provided an update to Committee regarding the recommendation from Heritage Richmond Hill related to the designation of 35 Wright Street. She advised that the property owner had requested additional time to consider alternative options for the dwelling and to present a new proposal.

Committee discussed the heritage attributes of the property and working towards keeping the heritage context alive at the street level.

#### 5. Re-establishment of Committee Sub-committees

J. Leung, Manager of Urban Design, provided background information regarding the role and purpose of the Heritage Designation sub-committee. Chair Thompson and Committee Members Lam and Kelly expressed interest in meeting with staff to review the designation criteria as part of identifying 5 properties to be considered for heritage designation. It was suggested that Committee Member Andre may also be interested in participating on the sub-committee.

Staff advised that the workshop that was being held following the Committee meeting would provide additional information related to the identification and evaluation of cultural heritage properties.

Staff further advised that the Heritage Grant sub-committee and the committee liaison with the Heritage Centre Advisory Committee would be further discussed.

#### **Delegation**

Colin McLachlan, addressed the Committee on behalf of Mansouri Group, regarding the application to demolish the William Neal House located at 41 Elgin Mills Road East. He noted that they were the new operators of Chrysler Richmond Hill. Mr. McLachlan explained that while they supported the designation of the property, the request to demolish the house was being submitted as there was no architectural merit to the structure. He indicated that the house was in poor condition and presented options that would acknowledge the significance of William Neal to the community. Mr. McLachlan requested support for the demolition permit and advised that they would work with staff on a site plan application that included a means to commemorate the history of the site.

Staff provided background information related to the Council decision to designate the property at 41 Elgin Mills Road East in 2012, and the owner's appeal of Council's decision to the Conservation Review Board. Staff advised that the Review Board upheld Council's decision, however recommended that reference to the "architectural" value be removed. In 2015, the designation by-law was deferred pending completion of a Flood remediation Class EA study which has now been completed.

Staff advised that an application to demolish the William Neal House and accessory structures was received on November 14, 2017 and that under the *Ontario Heritage Act*, Council has 90 days to consult with the Heritage Committee and to approve or deny the application. Staff confirmed that the cultural heritage value of the property has not changed and informed Committee that a development application had not been received for the property, noting that designation of the property did not preclude development.

Committee members discussed the findings of the Conservation Review Board that the building does not have architectural value. Committee members reviewed the designation process, the merits of the heritage designation and the condition of the dwelling, noting the importance of preservation of the site by the property owner.

Committee members generally agreed that the house contained significant associative value because of its direct association with William Neal and that the property had heritage significance and merits designation.
