# 1. Call to Order

The Mayor called the meeting to order at 9:30 a.m.

# 2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

Liz Bick, owner of 37 and 39 Centre Street West, addressed Council regarding the Notice of Intention to Designate 37 and 39 Centre Street West. She shared information regarding her family's history living at the property and growing up in Richmond Hill, advised of their intent to preserve the property and pass it down to future generations of her family,

and noted the many renovations they have undertaken to their home to maintain and restore its historical features. L. Bick advised that she did not want her property designated, citing the potential difficulties that would result, and requested that Council not approve the recommendations to designate 37 and 39 Centre Street West.

H. Doughty advised that he did not support the recommendation of the Integrity Commissioner to remove Member Li from the City of Richmond Hill Committee of Adjustment.

E. She advised of her concerns with the operations and oversight of the City of Richmond Hill Committee of Adjustment and advised that her concerns were not with Member Li. J. Langshaw shared her experiences with the City of Richmond Hill Committee of Adjustment related to a neighbouring property on Roseview Avenue and her support of Member Li; and requested that going forward, Committee of Adjustment meetings be recorded for visibility and transparency.

Whereas, unlike federal and provincial revenues, municipal tax revenue has not increased in recent years along with inflation, economic growth, or population growth; and

Whereas, municipalities are facing a gap in federal infrastructure funding as the 10-year Investing in Canada Infrastructure Program has come to an end, the Canada Community-Building Fund is being renegotiated and the Permanent Public Transit Fund is set to start in 2026;

Whereas, The Canada Community-Building Fund (CCBF), which was formerly known as the federal Gas Tax Fund, provides more than \$2 billion in annual capital funding directly to municipalities through a predictable allocation mechanism, and municipalities of all sizes use the CCBF to deliver direct results for Canadians by building and renewing critical core public infrastructure, including water infrastructure, local roads, public transit and community, and cultural and recreational facilities;

Now Therefore Be It Resolved:

That Council for the City of Richmond Hill requests that the Federal government work with municipalities and agreement signatories to maintain the Canada Community-Building Fund as a source of direct, predictable, long-term funding for local infrastructure priorities; and be it further resolved

That Council for the City of Richmond Hill requests the Federal government commit, in Budget 2024, to the next generation of infrastructure programs, including a new program for water and wastewater infrastructure and an increase to the Disaster Mitigation and Adaptation Fund; and be it further resolved

That Council for the City of Richmond Hill requests that the Federal government engage with provinces, territories and municipalities to negotiate a "Municipal Growth Framework" to modernize the way that municipalities are funded in order to enable Canada's long-term growth; and be it further resolved
